Richard Coupland III, is the vice president of Municipal Sales for Republic Services, responsible for partnerships with approximately 2400 municipalities across 42 states. His team provides consultative support to their Municipal partners, to understand and navigate changes in the industry, as well as emerging technology and methods.

Richard joined Republic Services in 2015, following a 20-year career in the defense industry with Fortune 100 companies including General Dynamics and Motorola.

Richard received his Bachelor of Science degree in Mechanical Engineering from the Virginia Military Institute, and his Masters degree in Business Administration from the W.P. Carey School of Business at Arizona State University.



Trevor Blythe has over 15 years of consulting experience with EcoNomics, Inc. in the sustainable materials management industry. Debbie Espinosa is the President & CEO of FIND Food Bank, the Feeding America food bank that serves the Palm Springs desert region of California. Serving in the NonProfit sector for over 25 years at the local, regional, national and international levels, her experiences include the Strategic Programs and Operations Consultant for the Global Foodbanking Network for the national food banking networks of Honduras, Nicaragua and El Salvador, Special Assistant to the CEO of Fair Trade USA and President of the Certified NonProfit Professionals Association. In '15 Baylor Univ. Business Review featured her for her business acumen in cross sector management. Currently, Debbie serves on the Feeding America National Advisory Council and the EDI National Advisory Cabinet, as an Officer of the NonProfit Leadership Alliance Board of Directors, and is a member of the Riverside County Emergency Food and Shelter Board of Directors. Under Mike's guidance, the organization became known as Abound Food Care, working to develop solutions across the country and beyond.


